Re: Your REQUIRED participation in Oregon's Quality Metrics Program

In 2017, the Oregon Legislative Assembly passed House Bill 3359 (codified as ORS 443.446 and 443.447). This law requires that a uniform quality metrics reporting system be developed to measure and compare the performance of residential care and assisted living facilities across the state. This reporting system is overseen by the Quality Measurement Council (Council).

During the Covid-19 pandemic, all RCFs and ALFs are still required to report in the quality metric application (QMA). However, due to the additional workload created by the pandemic, the Council made the decision to have facilities report in a yes and no format as to whether they have been tracking each metric during 2020. Revisions to the QMA have been completed. For facilities that do not report, it will be noted in the annual report.

To report in the QMA, at least one staff member from each facility must be registered to enter the information. Our records indicate that a facility you own or manage has not yet had a staff member register. The quality metrics application can be accessed at: <u>https://ltcfacilityportal.oregon.gov/.</u>
