# Standards for Training Programs for Nursing Assistants and Medication Aides

### 851-061-0010

#### **Purpose of Standards**

To foster the safe and effective performance of duties by graduates of nursing assistant and medication aide training programs by setting standards which promote adequate preparation of students. These standards will:

- (1) Serve as a guide for the development and approval of new nursing assistant and medication aide training programs.
- (2) Create minimum standards and provide general parameters for Board-approved curriculum of established nursing assistant and medication aide training programs.
- (3) Allow flexibility in the manner of teaching the required curriculum when not in conflict with the parameters of Board-approved curriculum.

#### **Definitions**

As used in these rules:

- (1) “Assisted Living Facility” means a facility that is licensed by the State of Oregon and as defined by the Oregon Department of Human Services.
- (2) “Board-approved Curriculum” means content required in nursing assistant and medication aide training programs established by Board policy.
- (3) “Certified Medication Aide (CMA)” means a Certified Nursing Assistant who has ~~[had]~~ **successfully completed** additional training in administration of noninjectable medication and holds a current Oregon CMA certificate.
- (4) “Certified Nursing Assistant (CNA)” means a person who holds a current Oregon CNA certificate by meeting the requirements specified in these rules; whose name is listed on the CNA Registry; and who assists licensed nursing personnel in the provision of nursing care. The phrase Certified Nursing Assistant and the acronym CNA are generic and may refer to CNA 1, CNA 2 or all CNAs.

- 1 (5) “Certified Nursing Assistant 1 (CNA 1)” means a person who holds a current Oregon CNA  
2 certificate and who assists licensed nursing personnel in the provision of nursing care.
- 3 (6) “Certified Nursing Assistant 2 (CNA 2)” means a CNA 1 who has ~~[met requirements specified~~  
4 ~~in these rules for one or more of the CNA 2 categories]~~**had additional training and**  
5 **competency validation in accordance with these rules.**
- 6 (7) “Client” means the individual who is provided care by the CNA or CMA including a person who  
7 may be referred to as “patient” or “resident” in some settings.
- 8 (8) “Clinical Instructor” means a registered nurse whose role is education of students in the skills  
9 laboratory or clinical site and who may participate in classroom teaching under the direction of  
10 the program director or primary instructor.
- 11 (9) “Clinical Preceptor” means a licensed nurse who provides direct clinical supervision of  
12 students during their clinical experience under the direction of the program director or a  
13 primary instructor.
- 14 (10) “Clinical Site” is a location or situation in which hands on experience with actual clients is  
15 obtained.
- 16 (11) “CNA Registry” means the listing of Oregon Certified Nursing Assistants maintained by the  
17 Board.
- 18 (12) “Competency evaluation” means the Board approved process for determining competency.
- 19 (13) “Criminal History Check” means the Oregon Criminal History Check and when required, a  
20 National Criminal History Check and/or a State-Specific Criminal History Check, and  
21 processes and procedures equivalent to the Department of Human Services (DHS) rules.
- 22 (14) “Direct supervision” means that the registered nurse, clinical nurse specialist, or nurse  
23 practitioner is physically present and accessible in the immediate client care area and is  
24 available to intervene if necessary.
- 25 (15) “Facility-Based Program” means an approved nursing assistant or medication aide training  
26 program in a licensed nursing facility.
- 27 (16) “Full-time” means at least 32 hours of regularly scheduled work each week.
- 28 (17) “Independent Training Program” means an approved nursing assistant or medication aide  
29 training program that is not a facility-based program.
- 30 (18) “Instructor-directed” means an on-line training that is managed, directed, and facilitated  
31 through interaction between learners and identified instructor(s). Learning activities may occur  
32 through either synchronous or asynchronous interaction between instructor and students and  
33 among students.
- 34 (19) “Level 1 training” is the minimum training required to prepare a graduate to take the state  
35 certification examination for CNA 1.
- 36 (20) “Level 2 training” is training available to a CNA 1 to prepare them for a role in ~~[one or more of~~  
37 ~~the Board approved category areas]~~ **performing additional Board approved authorized**  
38 **duties at the direction of a registered nurse.**
- 39 (21) “Licensed Nursing Facility” means a licensed nursing home or a Medicare or Medicaid certified  
40 long term care facility.
- 41 (22) “Nursing Assistant” means a person who assists licensed nursing personnel in the provision of  
42 nursing care. ORS 678.440(4)

- 1 (23) “On-line program” means an interactive computer based training program that provides at  
2 least the equivalent of the Board required classroom, laboratory, and clinical hours under the  
3 supervision of a Board approved instructor/preceptor.
- 4 (24) “On-line program provider” means a provider that has a proven track record of successfully  
5 providing professional development, training and educational programs in both classroom and  
6 on-line environments in Oregon, either directly or in partnership, in the previous 24 months of  
7 application, and meets all Board requirements.
- 8 (25) “Program” means a training program that prepares graduates for certification as a nursing  
9 assistant level 1, level 2, or medication aide. The terms “nursing assistant program, or  
10 “medication aide program” as used in these rules, are synonymous with “Program.”
- 11 (26) “Representative of the Board” means the Nursing Assistant Program Consultant or Board  
12 designee qualified to perform the necessary responsibilities.
- 13 (27) “Residential Care Facility” means a facility that is licensed by the State of Oregon and as  
14 defined by the Oregon Department of Human Services.
- 15 (28) “Self-directed” means an on-line program in which course materials, learning activities,  
16 communications, and assessment activities are delivered and completed electronically.  
17 Learners engage in and complete activities at their own pace.
- 18 (29) “Self-Evaluation” means a review of a basic nursing assistant or medication aide training  
19 program conducted by the program director using forms provided by the Board and submitted  
20 to the Board.
- 21 (30) “Site Visit” means that representative(s) of the Board go to the location of a program for  
22 specified purpose(s) which may include a survey for approval.
- 23 (31) “Standards for Approval” means authoritative statements which set expectations for a program  
24 to achieve and maintain approval status. (OAR 851-061-0080 through 0130).
- 25 (32) “Survey Visit” means that representative(s) of the Board go to the location of a program to  
26 review the program for compliance with Standards for Approval, and to prepare a report and  
27 recommendation regarding approval status.
- 28 (33) “Waiver of Prohibition” authorizes a program to be taught in but not by a facility that has had its  
29 approval denied or withdrawn pursuant to OAR 851-061-0050(2).

### 39 **Process for Program Approval**

- 40 (1) Any person, partnership, association, corporation, or limited liability company desiring to offer  
41 training other than just nursing assistant or medication aide training to non-employed students  
42 will need to be licensed through the Oregon Department of Education in addition to meeting  
43 the Board’s standards as described in these rules.

- 1 (2) All nursing assistant or medication aide training programs shall be Board-approved prior to  
2 being offered. Retroactive approval shall not be granted.
- 3 (3) Application for Initial Approval of level 1, level 2, and medication aide training programs. A  
4 facility, agency, on-line program provider, or individual wishing to establish a new nursing  
5 assistant or medication aide training program shall make application to the Board at least 45  
6 days in advance of expected start date. The application for initial approval of a training  
7 program shall include:
- 8 (a) A completed form provided by the Board;
  - 9 (b) Appropriate fees;
  - 10 (c) Faculty names and qualifications;
  - 11 (d) Names of classroom and clinical facilities;
  - 12 (e) Name of person authorized to accept service of notices issued by the Board;
  - 13 (f) Program rationale, philosophy and purpose;
  - 14 (g) Program outline:
    - 15 (A) Objectives;
    - 16 (B) Curriculum content divided into number and sequence of didactic and clinical  
17 hours; and
    - 18 (C) Teaching methodology.
  - 19 (h) Evaluation method:
    - 20 (A) Laboratory and clinical skills checklist approved by the Board;
    - 21 (B) Final exam; and
    - 22 (C) In addition, for level 2 training programs, a Board approved competency  
23 evaluation.
  - 24 (i) Enrollment agreement and disclosure statement that includes:
    - 25 (A) Beginning and ending dates of the training;
    - 26 (B) An outline of the instructional program as required by these rules for which the  
27 student is enrolled;
    - 28 (C) Fees, tuition, and other program costs (books, clothing, etc.) itemized  
29 separately;
    - 30 (D) A published cancellation and refund policy, procedure, and schedule that is fully  
31 explained during orientation, prior to the beginning of instruction, and requires  
32 no less than:
      - 33 (i) If the training program discontinues after the fees and tuition have been  
34 paid, the program provider must refund the tuition and fees in full if the  
35 closure happens before the course is completed;
      - 36 (ii) If the student cancels enrollment in writing three days before the  
37 commencement of the first day of classes or three days before they  
38 receive access to the online didactic training, all tuition and fees paid to  
39 the program specific to the enrollment agreement, will be refunded, less  
40 a cancellation fee that cannot exceed 10 percent of the tuition and fees  
41 paid; and
      - 42 (iii) Clearly stated reasons for which a refund will not be granted; and

- 1 (E) Information about how the student can file a complaint about the program with  
2 the Board.
- 3 (j) Tentative time schedule for initiating the program; and  
4 (k) Plan for what job placement assistance will consist of from the training program.
- 5 (4) A site visit may be conducted by a representative(s) of the Board;  
6 (5) The program director will be notified of approval or non-approval. Following receipt of  
7 notification from the Board of approval or non-approval:  
8 (a) A program that is approved may begin classes according to the schedule submitted;  
9 (b) A program that is not approved will be notified of the deficiencies and will be re-  
10 evaluated after appropriate modifications are made;  
11 (c) A program denied approval may petition the Board for reconsideration.
- 12 (6) An approved nursing assistant level 1 or medication aide training program:  
13 (a) Shall be required to demonstrate ongoing compliance with the standards of approval at  
14 least every two years for continued approval.  
15 (b) Shall be surveyed for consideration of continued approval and may have a survey visit  
16 or interim self-evaluation report required by the Board at any time.  
17 (c) May be subject to scheduled or non-scheduled site visits for continued approval or any  
18 other purpose at any time.  
19 (d) Shall submit an interim self evaluation during the intervening year or as requested by  
20 the Board on forms provided by the Board.  
21 (e) Shall have records available for review.  
22 (f) Shall have adequate financial support for the stability and continuation of the program.
- 23 (7) An on-line provider shall have a proven track record of successfully providing professional  
24 development, training and educational programs in both classroom and on-line environments  
25 in Oregon, either directly or in partnership, in the previous 24 months, and meet all Board  
26 requirements prior to being approved.
- 27 (8) Following initial approval, level 2 training programs remain approved unless specifically  
28 withdrawn by the Board.
- 29 (9) Program changes requiring Board approval:  
30 (a) Change of program ownership:  
31 (A) If the change only causes minor changes, there is no need to seek new  
32 approval of the program.  
33 (B) If the change causes a substantial difference as determined by the Board  
34 through the impact on the students, faculty, or program resources, an  
35 application and approval for the program shall be required.  
36 (b) Changes in course content, lab/clinical skill checklist, final exam, certificate of  
37 completion, program director, primary instructor, clinical instructor, clinical preceptor,  
38 policies and procedures related to attendance, course requirements, cancellation and  
39 refunds, or classroom or clinical training sites shall be submitted to the Board for  
40 approval.

### Inactive Status or Closure of a Program

8 (1) Voluntary Inactive Status. A training program may be granted temporary inactive status for up  
9 to two years:
- 10 (a) The program director shall notify the Board in writing of the intended inactive date and  
11 the plan for allowing the currently enrolled students to complete the program.
  - 12 (b) The program shall be continued until the committed class schedule of currently  
13 enrolled students is completed.
- 14 (2) Involuntary Inactive Status. A training program shall be placed on temporary inactive status for  
15 up to one year for the following reasons:
- 16 (a) To allow an opportunity for the program to take corrective action; or
  - 17 (b) After a period of 12 months during which no classes were taught.
- 18 (3) Process to reinstate active status: A training program may be reinstated subsequent to  
19 voluntary or involuntary inactive status by submitting satisfactory evidence that the program  
20 meets Board standards.
- 21 (4) Voluntary Closing. When a facility, institution or individual considers closing a nursing assistant  
22 training program, the program director shall:
- 23 (a) Notify the Board in writing of the intended closing date and the plan for allowing the  
24 currently enrolled students to complete the program.
  - 25 (b) Continue the program until the committed class schedule of currently enrolled students  
26 is completed.
  - 27 (c) Provide for the custody of the records:
    - 28 (A) If the nursing assistant or medication aide training program closes but the  
29 educational institution or licensed health care agency continues to function, the  
30 institution shall assume responsibility for the records of the students and the  
31 graduates. The Board of Nursing shall be advised of the arrangements made to  
32 safeguard the records.
    - 33 (B) If the facility-based or independent training program ceases to exist, the Board  
34 of Nursing shall be consulted about the maintenance of student records.

- 1 (1) The Board may deny or withdraw approval if standards for approval of new or existing nursing  
2 assistant level 1, level 2, or medication aide training programs are not being met:  
3 (a) Notice of the deficiency(ies) shall be given in writing to the program director;  
4 (b) The program director may submit evidence of correction to the Board;  
5 (c) The Board may withdraw program approval immediately or prescribe the time within  
6 which the deficiency(ies) shall be corrected;  
7 (d) The approval may be withdrawn, if the program fails to correct the deficiency(ies) within  
8 the time specified;  
9 (e) A program may request a hearing if the approval is withdrawn; and  
10 (f) The withdrawal may be effective after the last currently enrolled student has completed  
11 the program.
- 12 (2) Pursuant to Federal Regulations the Board shall deny approval to a nursing assistant training  
13 program and shall withdraw approval from a previously approved nursing assistant training  
14 program offered by or in a licensed nursing facility or a skilled nursing facility which, in the  
15 previous two years:  
16 (a) Has operated under a waiver of the federal requirement for nursing facilities and skilled  
17 nursing facilities to have 24 hour a day licensed nurse staffing with eight hour a day  
18 registered nurse staffing when such waiver is in excess of 48 hours per week; or  
19 (b) Has been determined by surveyors from the state Seniors and People with Disabilities  
20 Division or federal Center for Medicare and Medicaid Services to have conditions  
21 which pose an immediate threat to resident health and safety; or  
22 (c) Has been subject to an extended or partial extended survey, a restriction of admissions  
23 or an impending restriction of admissions for provision of substandard quality of care;  
24 or  
25 (d) Was subject to a denial of payment under federal law; or  
26 (e) Has had its Medicare participation terminated under federal or state law; or  
27 (f) Was assessed a civil penalty of \$5,000 or more, for deficiencies in nursing facility  
28 standards, except if waived pursuant to 42 CFR § 483.151; or  
29 (g) Has operated under trusteeship appointed to oversee the operation of the nursing  
30 facility and to ensure the health and safety of its residents; or  
31 (h) As a result of state action terminated the operation of the facility or was closed or has  
32 had its residents transferred.
- 33 (3) A program or facility that has had its approval denied or withdrawn pursuant to OAR 851-061-  
34 0050(2) may apply for waiver of prohibition if:  
35 (a) The facility has received written notice from Seniors and People with Disabilities  
36 Division's Client Care Monitoring Unit that it is in compliance with regulations governing  
37 licensure and/or certification; and  
38 (b) There is not another program within ten road-miles from the facility submitting the  
39 request.
- 40 (4) The letter of request for waiver of prohibition shall:  
41 (a) Address the distance in road-miles from the sanctioned facility to the closest program  
42 or facility that is willing and eligible for approval to serve as a clinical site for the training  
43 program; and

- 5 (6) The Board may withdraw program approval of a nursing assistant level 1 or medication aide  
6 training program if:
- 7 (a) The program cannot provide satisfactory evidence that the standards for nursing

10 (c) The average pass rate for graduates of the program falls below 85% over a two year

- 14 (a) Standards for program approval are not met as determined by a survey visit or interim  
15 self evaluation report which may be required by the Board at any time, for any purpose,  
16 and may be announced or unannounced; and  
17 (b) A site visit is not permitted or records are not available for review.
- 18 (8) When program approval is withdrawn, the program shall:
- 19 (a) Submit a plan to the Board within ten working days for completion of the currently  
20 enrolled students;  
21 (b) Allow students who have started a training program from which approval has been  
22 withdrawn to complete the course; and  
23 (c) Submit the required student information to the Board, using the Board approved  
24 format, when the students have completed the course.
- 25 (9) The Board may reinstate approval of the nursing assistant or medication aide training program  
26 upon submission of satisfactory evidence that the program meets the Board standards.

5 must be submitted to the Board containing the following information:

6 (a) Anticipated effects on students, faculty and resources; and

7 (b) Plans for the orderly transition of the program.

9 (a) Nursing assistant level 1 and medication aide training programs shall register with the  
10 Board:

11 (A) By the end of the second class day, the students':

13 (ii) Dates of birth;

15 (iv) Current addresses.

16 (B) Within two weeks of completion of a class, the students':

33 **Standards for Approval: Organization and Administration**

34 (1) Training program policies and procedures shall be in written form and shall be reviewed at  
35 least once every two years.

36 (2) Training programs implementing program changes cannot require students who are currently  
37 enrolled to complete the requirements of a revised program. Enrolled students are to be taught  
38 out under the program identified in their most current signed enrollment agreement.  
39 Exceptions may be allowed when and if the school and student mutually agree to the program  
40 change(s) and a new or amended enrollment agreement is negotiated, accepted, and signed  
41 by the student and school. Examples of program changes as used in this rule include, but are  
42 not limited to, increase or decrease of hours required, changes in the schedule of hours of

- 1 instruction, adding or dropping course requirements, increasing program costs or fees, or  
2 changes in the payment plan.
- 3 (3) Training program shall be financially viable for the stability and continuation of the program.
- 4 (a) Training program providers in assisted living, licensed nursing, and residential care  
5 facilities licensed by the Department of Human Services or the Health Authority and  
6 training programs licensed by the Department of Education are exempt from  
7 demonstrating financial viability to the Board.
- 8 (b) Training program providers not identified in OAR 851-061-0075(3)(a), will provide  
9 financial statements to demonstrate:
- 10 (A) Assets equal to or greater than liabilities;  
11 (B) No operating loss in any year of more than 10% of their net worth; and  
12 (C) No operating loss of any amount for two consecutive years.
- 13 (c) A training program that is unable to verify financial viability may be required to carry a  
14 bond, get a letter of credit, or escrow unearned tuition.
- 15 (4) All training program advertising, sales, collection, credit or other business practices are  
16 conducted in a manner that does not violate ORS 646.608.
